September is National Suicide Prevention Month

It is a time when we pay particular attention to helping those who might be in trouble. The danger signs of a potential suicide are seldom as obvious as those with many other emergencies. If you grasp your throat, most people would conclude that you're choking. If a person suffers a stroke, unmistakable signs that something is seriously wrong include a drooping face, inability to lift up both arms, or being incapable of completing a coherent sentence.

Suicides are different. Some victims exhibit few signs that something is amiss. Indeed, a potential suicide candidate might appear to be as normal as everyone else, until the tragedy happens. **READ MORE**

Important Reminders

Emergency and Activity Bags Available for CASA Children:

Emergency Bags: To be used when a child is in crisis, removed from the home, enters foster care or enters a homeless or domestic violence shelter. Bags are customized by gender (when appropriate) and for the following age groups: Infant, 3-5, 6-8, 9-11, 12-18.

Activity Bags: Useful as an ice breaker if visiting your child for the first time, or anytime you feel it would benefit him or her. Bags are customized by gender (when appropriate) and for ages 3-5 or 6-8.

The Bag Project Mission: The Bag Project seeks to provide every child in crisis with a high-quality, age-appropriate bag filled with basic necessities and comfort items which they may not otherwise receive.

What's in a Bag: Although children's needs are greater than that which can fit in a bag, a bag filled with necessities and comfort items is a start. It shows them that they matter, and that someone cares. Now they have a few items of their own, and a bag in which to put them. Anupa S.
